## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and the benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(a) and (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council shall have the power to manage all economic affairs and enterprises of the Three Affiliated Tribes, administer tribal property and funds, and make expenditures from available tribal funds; and
- WHEREAS, The administration of the Tribal Business Council, past and present, has purchased, leased, or traded for a number of vehicles to be utilized for administrative operations and program support to make our tribal government and enterprises more effective; and
- WHEREAS, The West Segment in Mandaree has many enrolled members who are unable to transport water, whether for cattle operations or drinking water, and other health and social crisis, etc.; and
- WHEREAS, The red extended cab pick-up was financed through Dakota West Credit Union of Watford City, ND with the final amount owed of \$5,597.25 at an interest rate of 1.5% per day after March 10, 2000, per Resolution #00-65-DSB at the Special Council Meeting dated February 11, 2000.
- **BE IT FINALLY RESOLVED,** That the Tribal Chairman or the Tribal Treasurer be authorized to sign any or all documents necessary to carry out this resolution.
