**RESOLUTION
OF THE
GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD RESERVATION**

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribes and of the enrolled members thereof, and

WHEREAS, Article VI, Section 5(i) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to make assignments and leases of Tribal lands, in accordance with the provisions of Article IX of the Constitution; and

WHEREAS, It has been determined that it is in the best interest of the Three Affiliated Tribes to develop additional housing for the members of the Tribe; and

WHEREAS, It is the considered judgment of the Tribal Business Council that the Tribes should, in conjunction with the Fort Berthold Housing Authority, make available Tribal lands for the development of Project ND-5-029 which involves the construction of an apartment complex in the Four Bears Segment of the Fort Berthold Reservation;

NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes, in conjunction with Fort Berthold Housing Authority, shall make available the Tribal lands described below for Project ND-5-029:

Allotment T538A-B, SW1/4NE1/4SW1/4NW1/4 Sec. 16, T. 152 N., R. 93 W., containing 2.50 acres, more or less

BE IT FURTHER RESOLVED, That the Natural Resources Department is hereby directed to prepare all necessary documents, such as Lease Agreement and Right-of-Way forms, for the development of the above-described project.
