RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer the funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and
- **WHEREAS**, Pow-wows are cultural events that occur in every segment of the reservation, and the Tribal Business Council has supplemented the cost of the Pow-wows in the past, and
- WHEREAS, The Tribal Business Council must cap the Pow-wow funding that is granted to the Pow-wow Committees and the council realizes that fundraising is extremely difficult for the segments due to the 4-Bears Casino Bingo and other charitable gambling competitors and
- NOW THEREFORE BE IT RESOLVED, Each Pow-wow Committee's donation from the Three Affiliated Tribes will be capped at a \$12,500.00 flat fee with a 100% match for funds raised. Bank statements need to be submitted along with a break-down of funds raised by the six Pow-wow Committees to the Tribal Business Council. The 100% tribal match is not to exceed \$20,000.00 and
- **BE IT FURTHER RESOLVED**, The resolution requirements for each Pow-wow Committee is as follows:
