WHEREAS,	The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof, and;
WHEREAS,	Article VI, Section 5(c), provides that the Tribal Business Council may administer any funds or property within the exclusive control of the Tribes to make expenditures from available Tribal funds, and;
WHEREAS,	It has been the desire of the Tribal Business Council of the Three Affiliated Tribes to assist its tribal enrolled members with Business Development loans to support opportunities for economic development projects on Fort Berthold; and
WHEREAS,	The Tribal Business Council has allowed that such economic development endeavors are authorized a matching tribal loan and business development grant; further, that Resolution #00-139-DSB authorized and appropriated a business development grant in the amount of \$3,500.00 to Cletus Packineau to assist with his established oil pumping service on Fort Berthold; finally, that Cletus Packineau has provided all documents relative to his on-going business to the Tribal Business Council;
NOW, THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby authorizes and appropriates a Business Development loan to Cletus Packineau in the amount of \$3,500.00 at an interest rate as described by the Small Loan program to enhance his well pumping and oil industry business, such funds to be disbursed as expeditiously as possible upon submission of required documents.
