

**RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION**

**WHEREAS,** This Nation, having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article VI, Section 5(c), provides that the Tribal Business Council may administer any funds or property within the exclusive control of the Tribes and may make expenditures from available Tribal funds; and

**WHEREAS,** The Tribal Business Council is supportive of the efforts of its enrolled members who pursue opportunities for economic development projects on the Fort Berthold Reservation; and

**WHEREAS,** The Tribal Business Council has provided that such economic development endeavors are supported in the form of authorized matching tribal loan and business development grant to individual tribal members; and

**WHEREAS,** The Tribal Business Council recognizes the effort of Barbara J. Gullickson Bruguier in pursuing a small business venture and chooses to extend its provision in support of small business development ventures specific to business development grant and matching tribal loan;

**NOW THEREFORE BE IT RESOLVED,** That the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, authorizes and appropriates a Business Development Grant in the amount of \$3,500.00 to Barbara J. Gullickson Bruguier to assist with her established small business venture,

**BE IT FURTHER RESOLVED,** That The Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation authorizes and appropriates a Business Development loan to Barbara J. Gullickson Bruguier in an amount not to exceed \$3,500.00 which is deemed as the matching tribal loan provided by the Governing Body of the Three Affiliated Tribes.
