- WHEREAS, Article VI, Section (C), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds or property within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purpose of the tribes; and
- WHEREAS, This request for assistance for a Tribal Elder was verbally approved in October of 1999 and,
- WHEREAS MEC Services of Garrison performed the requested repairs and,

NOW, THERFORE, BE IT RESOLVED, that the Tribal Business of the Three Affiliated Tribes hereby authorizes the amount of \$800.00 to be paid to MEC Services of Garrison for repairs done for Magdeline Yellow Bird.
