### RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes has been compensated by the United states Government for loss and infrastructures by the passage of Public-Law 102-575, 1992, the Three Affiliated Tribes and Standing Rock Sioux Equitable Compensation Act; and
- WHEREAS, P.L. 102-575 established a permanent fund of \$149.2 million dollars which shall be referred to as the Economic Recovery Fund; and
- WHEREAS, Only the interest earned from this fund can be used for Educational, Social Welfare, Economic Development and other programs subject to the approval of the Secretary of Interior; and
- WHEREAS, The Tribal Business Council passed Resolution #00-208-DSB for distribution of these funds of \$125,000.00 for each of the 6 segments; and
- WHEREAS, The White Shield Community Board will submit a budget according to the conditions set forth in the said Resolution; and
- WHEREAS, The White Shield Community Board presented the budget for approval of the \$125,000.00 to the White Shield Community at the regularly scheduled community meeting held on October 19, 2000; and
