

**RESOLUTION OF THE GOVERNING BODY
of the
THREE AFFILIATED TRIBES
of the
FORT BERTHOLD INDIAN RESERVATION**

WHEREAS, This Nation having accepted the Indian Reorganization act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 5(1) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal Government entities and Tribal Officials; and

WHEREAS, It has been the practice of the Tribal Business Council members to make individual appointments for their respective segments to such Boards, Committees and Commissions that are within the authority of the Tribal Business Council; and

WHEREAS, The November 9, 2000 election has caused a change in the Tribal Business Council membership, where Randy Phelan is elected to serve a four year term on the Tribal Business Council; and

NOW, THEREFORE, BE IT RESLOVED That Randy Phelan Mandaree Council Representative of the Tribal Business Council hereby makes the following appointments to the following Boards, Commissions and Committees:
