- WHEREAS, This Nation, having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribe and the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes have been notified by the Aberdeen Regional Road Engineer, that they are eligible to receive \$32,589 for planning and design of bridges, and
- WHEREAS, The Three Affiliated Tribes have entered into an agreement with the North Dakota Department of Transportation to perform the planning and design of a bridge to replace the Four Bears Bridge, and

NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council hereby submits a scope of work and budget in the amount of \$32,589.00 for the planning and design of the new bridge, and

NOW, THEREFORE, BE IT FURTHER RESOLVED, That the Three Affiliated Tribal Business Council requests the Aberdeen Regional Contracting Officer to develop and approve a P.L. 93-638 contract in the amount of \$32,589.00 for the planning and design of the new bridge.
