- WHEREAS, The Three Affiliated Tribes Veterans Service
 Office wishes to pay homage to all triballyenrolled veterans of the each of the United States
 military service organizations by sponsoring a
 program and meal to be held at the 4Bears Park on
 May 28,2001; and
- WHEREAS, The Three Affiliated Tribes Tribal Business
