RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section ©, of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer and funds or property within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purpose of the tribes; and
- WHEREAS, The Tribal Business Council requires that previous to the release of any Tribal funds for the purpose of assisting individual Tribal member's economic or business development proposals, such proposals shall be complete and financially sounds, and provide business documents; and proof of financial commitment from resources other than Tribal, as well as any and all other information necessary for the Council to make a determination as to the business feasibility; and
- WHEREAS, The Three Affiliated Tribes Tribal Business Council has verified that tribal-enrolled member <u>Lloyd Vigen #301-U-5517</u>, currently owns and operates a business on the Fort Berthold Indian Reservation, and is in need of financial assistance to improve his business; and
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council does hereby appropriate to <u>Lloyd Vigen</u> a owned Tribal Business the following: <u>\$3,500</u> Business Development Grant and a <u>\$3,500</u> Business Development Loan; such monies being appropriated from Tribal revenues, subject to availability of funds and proof of the financial commitment and acquisition of outside resources.



- WHEREAS, This Nation, having accepted the Indian Reorganization Act of June 8,1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribe and the enrolled members thereof; and
 - WHEREAS, The Wells Road is on the approved Road Construction Priority Listing for fiscal year 2002, and
 - NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council hereby requests the
 - Bureau of Indian Affairs to issue the Three Affiliated Tribes a contract in the amount of \$39,000 for the survey and design of the Wells Road, as authorized by 23 USC.
