## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to adopt resolutions regulating the procedure of the Tribal Business Council, other Tribal Government entities, and Tribal officials; and
- WHEREAS, The Three Affiliated Tribes will assume added responsibility for the provision of higher education services on the Fort Berthold Reservation by providing funding on an annual basis through the Equitable Compensation Act, Public Law 120-575, October 30, 1992 (JTAC) competitive pool funds; and
- WHEREAS, The Tribal Business Council deems it necessary to continue the Tribalization of education on the Fort Berthold Reservation through the establishment of the JTAC-Educational Grants policies developed under the direction of the Education Committee, which were formally approved pursuant to Tribal Resolution #00-326-AG – September 1, 2000; and
- **WHEREAS,** The purpose of the funds is to establish added higher education funds to fund the unmet need for enrolled members that are continuing their education goals, that will benefit their quality of life and education; and
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council hereby approves from FY 2002 JTAC Funds for the Summer Session 2001 in the amount of \$25,000.00 for the Higher Education Grant Program; and \$10,000.00 for the Employment Training Program (477).

## CERTIFICATION
