- **WHEREAS**, the *Tourism and Independence Development Center* is coordinating many tourism and business related projects located on the Fort Berthold Indian Reservation; and
- WHEREAS, Tourism and Independence Development Center includes the following programs: the Tourism Department, the Independence Program, The Tribal Business Information Center, the Administration of Native Americans(ANA) Project -Mandan, Hidatsa, Arikara Cultural Interpretive Center Fund Raising Activities and the Nueta, Hidatsa, Sahnish Arts Cooperative.
- WHEREAS, The Table Butte Ceramics and Quilts business established by Rachel Grady no longer desires to continue to lease of the property located at 336 Main Street, New Town, ND 58763, from the Three Affiliated Tribes and administer the Nueta, Hidatsa, Sahnish Arts Cooperative.

NOW, THEREFORE, BE IT RESOLVED, The property located at 336 Main Street, New Town, ND 58763(known as the "Pawn Shop") is to be the new *Tourism and Independence Development Center* to house the Tourism Department, the Independence Program, The Tribal Business Information Center, the ANA Project - Mandan, Hidatsa, Arikara Cultural Interpretive Center Fund Raising Activities and the Nueta, Hidatsa, Sahnish Arts Cooperative.
