- WHEREAS, The Tribal Business Council recognizes the Fort Berthold Consortium comprised of Educational Institutions and Tribal Programs Service Providers, including all Fort Berthold Schools, 477-Program and Voc-Rehab, parents and students; and

NOW THEREFORE BE IT RESOLVED that the Three Affiliated Tribes Business Council authorizes the Fort Berthold Consortium to apply for grants to the US Department of Education, under the Talent Search and Educational Opportunity Centers Programs, CFDA #:84.044.

Talent Search Program

The Talent Search program identified individuals from disadvantaged backgrounds who have the potential to succeed in higher education. The program provides academic, career, and financial counseling to its participants and encourages them to graduate from high school and continue on to the postsecondary school of their choice. Talent Search also serves high school dropouts by encouraging them to reenter the educational system and complete their education. The goal of Talent Search is to increase the number of youth from disadvantaged backgrounds who complete high school and enroll in the postsecondary education institution of their choice.

Services Provided by the Program:

- Academic, financial, career, or personal counseling including advice on entry or re-entry to secondary or postsecondary programs
- Career exploration and aptitude assessment
- · Tutorial services
- Information on postsecondary education
- Exposure to college campuses

- Assistance in preparing for college entrance exams
- Mentoring programs
