- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls and;
- WHEREAS, Dillon Isacc Dixon, 301U-10778 requested relinquishment of his/her membership from the Three Affiliated Tribes, Membership has been requested and approved with the Isleta Pueblo of Albuquerque, NM, and
- WHEREAS, A copy has been received of application confirmation from the Southern Pueblo Agency for Dillon Isacc Dixon.
- NOW THEREFORE BE IT RESOLVED, that Dillon Isacc Dixon, 3 0 1U-1 0 7 7 8 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.
- BE IT FURTHER RESOLVED, that the Southern Pueblo Agency is to be advised by a copy of this resolution.
