OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Hiring Jay Leitch as an expert in the case of 'Three Affiliated Tribes v. Norton'"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 3(c) of the Three Affiliated Tribes Constitution specifically authorizes and empowers the Tribal Business Council to administer any funds within the exclusive control of the Tribe and to make expenditures from available Tribal funds for the public purposes of the Tribe, including payment of salaries and other compensation to Tribal officials and employees, which includes consultants and legal counsel; and
- WHEREAS, the Tribal Business Council has engaged the firm of Conlon, Frantz, Phelan and Pires of Washington, D.C., to represent the Three Affiliated Tribes in a Federal lawsuit being brought against the Department of Interior for failure to properly manage the trust funds and other assets of the Tribe held in trust for the Tribe by the United States; and
- WHEREAS, counsel for the Tribe has recommended that an expert be hired in the case who could properly assess damages to the Tribe caused by the mismanagement of tribal resources by the Federal government, and has recommended that Jay Leitch, Dean of the University of North Dakota School of Law, be hired for this purpose, and has requested that the Tribe pay for the cost of hiring Mr. Leitch; and
- WHEREAS, the hourly rate for Mr. Leitch is \$165 per hour in state and \$220 out of state plus reasonable expenses, and it is not yet clear how many hours Mr. Leitch will be needed in this matter;

- 1. We have discussed with Jay Leitch, Dean of the University of North Dakota School of Business, the possibility of him working on the case as an expert. His role would be to provide an assessment of damages. Enclosed is a copy of his c.v.
- 2. We do not yet have a contract with Dean Leitch. The tribe would have to pay his fees and expenses. We would like to bring him to Washington, DC, so that we can meet him. What do you need in order for the tribe to authorize payment of his fees and expenses? (Dean Leitch's hourly rate is \$165 in-state, \$220 out-of-state).
- 3. The government has proposed that we attend a seminar with accountants from the firm of Chavarria, Dunne, and Lamey to explain the Arthur Andersen Reconciliation Report. The seminar will take place in Washington, DC. Dean Leitch would like to attend. Perhaps you both would like to attend the seminar, and we could all meet Dean Leitch at that time. We tentatively scheduled the seminar for October 21, 2002, but need to reschedule because time has run short. We are working on a new date. Please let us know if you would like to attend, and when you would be available.
- 4. In sum, the case is moving forward. There will be expenses that the tribe will have to cover. The sooner we learn from you how that process works, the better we can provide you what you need.
