RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the Authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit or the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes;
- WHEREAS, The Elders of the Three Affiliated Tribes have suffered tremendous losses when they were forcibly removed from their homelands on the river-bottoms along the Missouri River; and
- WHEREAS, The Tribal Council of the Three Affiliated Tribes values and respects the collective knowledge of the Tribal Elders and wishes to pay tribute to the Elders and to acknowledge the losses they endured in their forced removal; and
- WHEREAS, The Tribal Council of the Three Affiliated Tribes during this Christmas season wishes to pay tribute and honor the remaining elders of the Three Affiliated Tribes by hosting a Christmas Dinner for these Elders; and

NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the amount of \$1,897.00 to pay for an Elders Christmas Dinner to be held at the Four Bears Casino and Lodge Special Events Center on December 19, 2002.
