- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS. The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes Business Council recognizes the need to have telephone service to all households on the Fort Berthold Reservation; and
- WHEREAS. The Three Affiliated Tribes has received a bid in the amount of \$11,910 from West River Telecom, that is the portion of the amount due once the grant is received; and
- NOW THEREFORE BE IT RESOLVED, the Three Affiliated Tribes Tribal Business Council hereby agrees to pay one-half of the needed dollar amount, (\$5,955) and the Twin Buttes Community will match the remaining portion (\$5,995).
