- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the Authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof, and
- WHEREAS, Article VI. Section 5 c of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council shall have the power to administer funds and make expenditures; and
- WHEREAS, The Tribal Business Council approved Resolution #01-275-MWJR "establishing a set amount of \$2,500.00 for recognized organizations that hold one/two day cultural events through out the calendar year"; and
- WHEREAS, The Old Scout Society is requesting funds in the amount of \$3,120.00 for their annual one-day cultural event held during the Memorial Day week-end and;
- WHEREAS, The Tribal Business Council approved on December 26, 2001 at their Special Council Meeting an extra two-thousand dollars for the Mid-Winter Pow-Wow, giving them \$3,500 per day, with a total of \$7,000.00 for their two day cultural event; and
- WHEREAS, The Old Scout Society according to the Resolution #02-275-MWJR falls into the category as a recognized organization; and
- **WHEREAS,** The Tribal Treasurer and White Shield Tribal Representative, Austin Gillette is requesting an additional one-thousand dollars for the Old Scout Society making the total \$3,500.00 for their one day cultural activity; and

NOW, THEREFORE BE IT FURTHER RESOLVED, The Tribal Business Council does hereby approve the additional one-thousand dollars to the Old Scout Society for their one-day cultural event to be held during the Memorial Day week-end
