RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorization to allocate a grant funding to the Veteran's Service Office for an Honoring Ceremony for all departed military veterans" This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the WHEREAS, authority under said Act; and WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and WHEREAS. Article IV, Section 5(c), provides that the Tribal Business Council may adminster any funds or property within the exclusive control of the Tribes to make expenditures from available Tribal funds; and WHEREAS, The Three Affiliated Tribes Veteran's Service Office wishes to pay homage to all triballyenrolled veterans of each of the United States military service branches by sponsoring a program and meal to be held at the Four Bears Casino Events Center on May 27, 2002, and also assisting our American Legion and VFW Posts with their annual three-day salute to all our departed comrades who now lie in our 34 Fort Berthold cemeteries; and The Three Affiliated Tribes Tribal Business Council commends the Veteran's Service WHEREAS. Office for their desire to honor the TAT veterans in this manner and hereby most respectfully acknowledges that the foundation of military service is freedom of life and liberty for all mankind; and WHEREAS, The Tribal Business Council is desirous of assisting the Veteran's Service Office in carrying out this most respectful ceremony; and NOW THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes Tribal Business Council does hereby provide a grant in the amount of \$5,300 from tribal funds for the purpose of assisting the TAT Veteran's Service Office with the honoring of all our departed military veterans as described above.
