

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorization to allocate \$141,500 to provide match funding for Pouch Point, Charging Eagle Bay and Skunk Bay recreation areas"

- **WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Friends of Lake Sakakawea worked with Senator Dorgan's office to secure funds for low water access to the lake for Recreation sites on Lake Sakakawea in the amount of \$700,000; and
- WHEREAS, The Tribes Recreation Areas were represented by the Water Resources Director, including Pouch Point, Four Bears Casino, Skunk Bay and Charging Eagle Bay during this process; and
- WHEREAS, The funds will be disbursed and administered by the Corp of Engineers; and
- **WHEREAS,** It was determined that this money would be a seventy five percent (75 %) cost share with twenty five percent (25 %) provided by the recreation managers; and
- WHEREAS, The Four Bears Casino indicated they would be financially responsible for their match;
- NOW, THEREFORE, BE IT RESOLVED, That The Three Affiliated Tribes allocate thirty thousand dollars (\$30,000) covering the match for Pouch Point, Charging Eagle Bay and Skunk Bay, securing One Hundred Forty One Thousand Five Hundred dollars (\$141,500) of the Friends of Lake Sakakawea money.
