A Resolution entitled, "638 Gravel Projects Per TIP RESOLUTION # 99-107"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes 'Tribal Business Council has determined that the Bureau of Indian Affairs should proceed with the PL 93-638 process to contract with the Three Affiliated Tribes, to plan, design and the construction of several highways and street projects, and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council hereby express their desire to proceed with item # 2 on the Transportation Improvement List (TIP) Regraveling several routes, designated on Resolution # 99-107.

NOW THEREFORE BE IT RESOLVED, The Three Affiliated Business Council does hereby approve to expedite this project as soon as possible.

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated generally authorized and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof, and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council recognizes the need for an adequate transportation system to provide access and services for the traveling public, and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has determined that the Bureau of Indian Affairs should proceed with the PL 93-638 process to contract with the Three Affiliated Tribes, to plan, design and the construction of several highway and street projects, and
- WHEREAS, The Three Affiliated Tribes doe recognizes the need and requirement by the Bureau of Indian Affairs via the Federal Highway Administration to develop and maintain a Transportation Improvement List(TIP), and
- WHEREAS, The Three Affiliated Tribes' Council acknowledge that projects may be moved up or down the priority list, depending on the availability of funding and additional co-operative funding from other governments and agencies.
- WHEREAS, The Three Affiliated Tribes' Council has met and does recommend for approval, the Transportation Improvement List to be revise as follows;
 - 1. Replacement of Four Bears Bridge, PS&E
 - 2. Re-gravel Routes 22 East, 20, 11, 10, 13, 14, 15, 602, 607, 7, 1,101, 3, 1820, 1810, 5, 24, and 9.

 - 5. Reservation wide Community Development Planning and Surveys
