

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Missouri River Trail Development Task Force

- **WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, United States Senator Kent Conrad has encouraged the U.S. Army Corps of Engineers to develop a Lewis & Clark Nature Trail along the original path taken by the Lewis and Clark Expedition of 1804-1805 in North Dakota; and
- WHEREAS, Senator Kent Conrad has supported the development of a Task Force to engage in planning and discussion on the development of a world class nature based trail along the Missouri River in North Dakota; and
- WHEREAS, the proposed Missouri River nature based trail traverses the Fort Berthold Reservation providing the Three Affiliated Tribes with an opportunity for development of biking, hiking, horseback riding, canoing, and other nature based trails; and
- **WHEREAS**, Senator Kent Conrad's office is encouraging participation of the Three Affiliated Tribes in the planning of the Missouri River trail system; and
- NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby designates Scott Eagle and Amy Mossett of the Tourism and Independence Center, and Paul Danks and Fred Fox of the Natural Resources GIS Division to serve as the Mandan, Hidatsa, Arikara representatives on Senator Conrad's Missouri River Nature Trail Development Task Force.

Dear Lieutenant General Flowers:

I encourage the Corps of Engineers to develop a Lewis & Clark Nature Trail along the original path taken by the Lewis and Clark Expedition in 1804-05 in North Dakota.

The entire Missouri River Corridor in North Dakota holds remarkable potential for hiking, birding, biking, backpacking, winter camping, photography, cross country skiing, and the study of unique flora and fauna first recorded by Lewis and Clark. In addition, North Dakotans feel a very special connection to the approaching Lewis and Clark Bicentennial because of the extensive amount of time these famous explorers spent along the Missouri River corridor in our state. After two hundred years, much of the natural beauty of the Missouri River within North Dakota remains intact for visitors to enjoy.

In my view, a nature trail would be an important first step in providing increased public access along the corridor and would significantly add to the quality of life for residents and visitors of all ages. Also, it would provide an excellent way to celebrate the cultural heritage of the Lewis and Clark Expedition in North Dakota. I believe such a nature trail would be low-cost, low-impact, and would gain the strong support of stakeholders in the area.

I am encouraged that we are able to work together so effectively on other priorities for the people of North Dakota and look forward to continuing to work with you closely as you develop a response to this request.
