## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (c), provides that the Tribal Business Council may administer any funds or property within the exclusive control of the Tribes to make expenditures from available tribal funds; and
- WHEREAS, Since October 1, 1997, the Tribe has been eligible to receive interest from the Economic Recovery Fund created by Congress under the Equitable Compensation Act of the Three Affiliated Tribes and the Standing rock Sioux Tribe (the "Act"), Title XXXV of P.L. 102-575, 106 Stat. 4731, for the benefit of the Three Affiliated Tribes and its members;
- WHEREAS, The enrolled members of the Three Affiliated Tribes have experienced the negative effects of alcoholism and substance abuse thereof; and these effects/affects are reflected not only in statistical morbidity/mortality rates, but also in the very homes and communities that the future generations of this Nation are nurtured in, on Fort Berthold Indian Reservation; and
- WHEREAS, The dysfunctional side effects of alcoholism and substance abuse are now conducive to the Spiritual, Emotional, Mental and Physical well-being to promote healthy life-styles or the general welfare, culture and the existence of the Mandan, Hidatsa and Arikara Nation; and whereas addiction (alcoholism and substance abuse) is a destructive chronic treatable disease; and
- WHEREAS, The Parshall Resource Center (PRC) is a 501 (c) 3, nonprofit organization that facilitates Social Detoxification and Residential Services for individuals in recovery 24 hours per day, 7 days per week thereof,; and this innovative culturally relevant recovery program provides streamlined, community based recovery services that are accessible for the enrolled members of the Three Affiliated Tribes, with positive results; and

- WHEREAS, The Parshall Resource Center is at this time attempting to secure emergency funding to support operating expenses in order to continue providing recovery services, and enhance the continuum of care for those who suffer from alcoholism and substance abuse; and
- WHEREAS, The Parshall Resource Center has not been contracted with the North Dakota Department of Human Services, through its regional human service centers, and the contract executed by the North Central Human Service Center for the provision of Social Detoxification and Residential Services expired June 30, 2001. Due to this expiration of the State Contract the PRC has only been collecting monies from the Tribe.
- **WHEREAS,** This "emergency funding" will assist the PRC to keep providing services until the proposed contract between the TAT and state is renewed; and the 2002-2003 encumbrance resolution for the PRC is approved for the next fiscal year; and
- **NOW THEREFORE BE IT RESOLVED,** that the Tribal Business Council hereby supports the mission and philosophy of the Parshall Resource Center and pledges to assist the delivery of recovery services on Fort Berthold Indian Reservation; and

**BE IT FINALLY RESOLVED,** That the Tribal Business Council hereby approves a \$10,000.00 emergency expenditure from JTAC funds for the month of September, 2002 for line item deficit expenditures. Let it be known that the Parshall Resource Center currently has in excess of \$9,080.01 in outstanding debts and; safety repairs in the amount of \$4,779.00 required to secure state funding currently all eight (8) residential beds at the PRC are full.
