### A Resolution entitled, "Authorization for the White Shield C-Store"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arickara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribal Business Council has authorized councilmen to oversee and administer projects in their respective districts/segments and,
- WHEREAS, The General Fund Budget FY02 approved one-hundred thousand dollars for the construction of a C-Store in the White Shield (Eastern) District/Segment, and
- WHEREAS, Councilman Gillette, White Shield Tribal Representative has given the White Shield Community Board to set the criteria for the Management/Lease of the C-Store, and
- WHEREAS, The Management/Lease has been advertisement and published in the various local newspapers McLean Independent, New Town News and MHA Times, with the deadline, February 14, 2003 for submitting proposals, and
- NOW, THEREFORE, BE IT FURTHER RESOLVED, The Tribal Business Council authorizes Councilman Gillette to review and select the person(s) or organization who have submitted their proposal with the required documentation set forth in the advertisement for the Management/Lease of the White Shield C-Store.
