

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Tribal Business Council support for Tribal Youth Program Cooperative Agreement Application"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, the Three Affiliated Tribes is requesting \$300,000 from the Office of Juvenile Justice and Delinquency Prevention for a cooperative agreement to assist in assuring that the Three Affiliated Tribes tribal youth are properly served by the Juvenile Justice system; and

WHEREAS, the cooperative agreement will be used for the specific purposes of:

- 1. Providing interventions for court-involved youth;
- 2. Improvement of the tribal juvenile justice system; and

WHEREAS, the Mandan, Hidatsa & Arikara Tribal Business Council considers the reduction of juvenile offenses and reduction of recidivism as an integral component to insure the survival of the Three Affiliated Tribes as a whole; and

NOW, THEREFORE BE IT RESOLVED, that the Mandan, Hidatsa & Arikara Tribal Business Council of the Fort Berthold Reservation hereby fully supports and authorizes the submission of a Juvenile Justice and Delinquency Program proposal to serve our Native American youth offenders under OJJDP Program announcement FY 2003 in the amount of \$300,000.
