

OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Tribal Request that the BIA exercise appropriate fiduciary responsibility to the Fort Berthold Agency and the members of the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Bureau of Indian Affairs Central Office has a carry over from the FY2002 budget in the amount of \$8 million dollars for the Great Plains Region; and
- WHEREAS, These funds have been allocated for Trust Services within the Bureau of Indian Affairs; and
- WHEREAS, The Bureau of Indian Affairs Fort Berthold Agency has a trust responsibility to manage appropriately the 986,000 acres that lie within the Fort Berthold Reservation exterior boundaries; and
- WHEREAS, The BIA Fort Berthold Agency has a voluminous backlog of Realty and Range functions which are not being accomplished due to a severe lack of staffing; and
- WHEREAS, The Tribe and BIA Fort Berthold Agency has identified the need for 19 positions which, if filled, would cost \$958,000 dollars annually in order to adequately address the fundamental trust responsibility as mandated by Tribal resolution, Federal regulations and statute; and
- WHEREAS, The Three Affiliated Tribes has identified a similar need in the amount of \$1.4 million dollars to address all of our resource management responsibilities of the Natural Resources Department; and
- NOW, THEREFORE BE IT RESOLVED, The Three Affiliated Tribes demand that the carryover funds available in the amount of \$2.4 million dollars be allocated to the above-mentioned programs for the needs outlined.
