

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "CHALLENGE WALK"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The incidence of diseases such as diabetes and heart disease is inordinately high for the people of the Three Affiliated Tribes; and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes and its Tribal Chairman have declared a "War on Diabetes" and wish to bring attention to the health problems on the Fort Berthold Reservation and ways to combat them through diet and exercise; and
- WHEREAS, Certain members of the Tribes through their efforts have presented before the Tribal Business Council a proposal to have a "Challenge Walk," or a walk around the Reservation, to bring attention to the health problems on the Reservation and ways to combat them, including by preventative means; and
- WHEREAS, The "Challenge Walk" is scheduled to be held on May 21-30, 2003 and is completely voluntary, and the Tribal Business Council wishes to encourage participation by as many people as possible; and
- WHEREAS, The Tribal Business Council has considered the matter and finds that it is in the welfare of the Tribes and the members thereof to support a safely-managed "Challenge Walk;"
- NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby supports a safely-managed "Challenge Walk," which is a walk around the Fort Berthold Reservation to be held May 21st –30th, 2003 and which has the goal of bringing attention to health problems on the Fort Berthold Reservation and ways to combat those problems; and
- FURTHER, BE IT RESOLVED, the Tribal Business Council hereby authorizes an employee of the Three Affiliated Tribes to take up to two days of Administrative Leave, after proper notification to his or her supervisor and if workload would not



prevent the employee from timely finishing his or her duties, in order to participate in the "Challenge Walk;" and

FINALLY, BE IT RESOLVED, a Tribal employee participating in the event must sign in at the "Challenge Walk" at three pre-determined times or the leave taken will be Leave Without Pay and subjects the employee to other disciplinary action in accordance with the Three Affiliated Tribes' Employee Policies and Procedures.
