

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

A Resolution entitled "Memorials One Time Grant"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the Authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(c), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds or property within the exclusive control of the Tribes and to make expenditures from available Tribal funds for the public purpose of the Tribes; and
- WHEREAS, The Tribal Business Council enacted Resolution #00-207-DSB setting a cap for monetary requests for Memorials at \$250.00 per family per year up to four years to an enrolled family member to sponsor a memorial for their deceased family member; and
- WHEREAS, Some Tribal members have asked for and erroneously received a lump sum of a \$1,000.00 grant for all of the four years which was not authorized under Resolution #00-207-DSB; and
- **WHEREAS,** The Tribal Business Council would like to be fair to all Tribal members they would approve to rescinded Resolution #00-207-DSB; and
- WHEREAS, The Tribal Business Council approves a one time grant of \$500.00 to a family member to conduct a memorial for their deceased family member; and
- **WHEREAS,** The Tribal Business Council actions of this one time grant of five-hundred dollars is effective from this day forward and will not be retroactive; and
- **NOW, THEREFORE BE IT FURTHER RESOLVED,** that the Three Affiliated Tribes Business Council hereby authorizes and appropriates the amount of five-hundred dollars to family members to conduct their memorials for their deceased family member; and
- **FINALLY BE IT RESOLVED,** This Resolution will be a standing resolution until the Tribal Business Council acts to change or amend it in any way and it will supercede Resolution #00-207-DSB and any other Resolutions before.
