WHEREAS,	This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
WHEREAS,	The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
WHEREAS,	This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
WHEREAS,	The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
WHEREAS,	Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer the funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and
WHEREAS,	Twin Buttes Custom Homes, a tribally owned corporation, being in existence since June of 2000, obtained a line of credit from Community First National Bank, Dickinson, North Dakota in the amount of \$400,000.00; and obtained a \$100,000.00 letter of credit by and through Minot Builders; and secured a \$100,000 letter of credit for bonding purposes; and
WHEREAS,	Twin Buttes Custom Homes has drawn on its line of credit from Community First National Bank in the amount of \$400,000.00 depleting its total line of credit and has drawn on its letter of credit from Minot Builders; and
WHEREAS,	The Three Affiliated Tribes has pledged as collateral against the line of credit and two (2) letters of credit, two (2) Certificates of Deposit one in

WHEREAS,	In order to continue to collateralize the above referred to debt, the

Certificate of Deposit subject here, must be renewed and pledged as



collateral for an additional 12 months beyond the existing maturity date; and

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby directs Community First Bank to reissue CD#6420306906 for a new maturity date of October 12, 2004 and that further the Certificate of Deposit herein pledged as security against the Minot Builders line of credit; and
