*A Resolution entitled, "Authorization to relinquish membership for Dakotah Blaze White, 301U-11173"*

**WHEREAS**, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

**WHEREAS**, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS**, the Constitution and By-laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

**WHEREAS**, Dakotah Blaze White, 301U-11173, requested relinquishment of his/her membership from the Three Affiliated Tribes. Membership has been requested and approved with the Spirit Lake Sioux Nation, Fort Totten, North Dakota; and

**WHEREAS**, a copy has been received of application confirmation from the Spirit Lake Sioux Nation.

**NOW, THEREFORE BE IT RESOLVED**, that Dakotah Blaze White, 301U-11173, is hereby relinquished from the official membership roll of the Three Affiliated Tribes.


**BE IT FURTHER RESOLVED**, that the Spirit Lake Sioux Tribe is to be advised with a copy of this resolution.


**CERTIFICATION**
