

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorization to relinquish membership of Little Crow Owen Baker, 301U-6687"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

WHEREAS, Little Crow Owen Baker, 301U-6687 requested relinquishment of his/her membership from the Three Affiliated Tribes. Membership has been requested and approved with the Crow Tribe, Crow Agency Montana; and

WHEREAS, a copy has been received of application confirmation from the Crow Tribe; and

NOW, THEREFORE BE IT RESOLVED, that Little Crow Owen Baker, 301U-6687 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.

BE IT FURTHER RESOLVED, that the Crow Tribe is to be advised by a copy of this resolution.
