



**RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES  
OF THE FORT BERTHOLD RESERVATION**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes general authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof and,

**WHEREAS,** On October 7, 1992, the Tribes signed a Tribal-State Class III Gaming Compact, between itself and the State of North Dakota pursuant to the Indian Gaming Regulatory Act (IGRA), 23 U.S.C. Sections 2701 et seq., which was approved by the Department of the Interior on December 11, 1992; and

**WHEREAS,** On October 14, 1992, the Tribal business Council enacted a Class III Gaming Ordinance, last amended in March 8, 1995, which has been approved by the National Indian Gaming Commission; and

**WHEREAS,** Pursuant to Resolution No. 00-13-DSB adopted on January 18, 2000, the Tribal Business Council assumed the role of overall management of the 4 Bears Casino and Lodge; and

**WHEREAS,** The Tribal Business Council determined that the Executive Committee of the Tribal Business Council would assume the role of the Tribal Enterprise Board; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council gives authority for the management of the 4 Bears Casino and Lodge to process payroll and accounts payable checks for normal operations of the casino; and

**THEREFORE BE IT FURTHER RESOLVED,** that the Council has determined that, because of personnel changes leaving only three people authorized to sign checks for the 4 Bears Casino and Lodge, that this could negatively affect the timeliness in which checks are issued; and

**THEREFORE BE IT FURTHER RESOLVED,** that it would be in the best interest of 4 Bears Casino and Lodge to add a fourth signatory; and



**THEREFORE, BE IT FURTHER RESOLVED**, that the Council hereby directs that, at a minimum, checks issued by the 4 Bears Casino & Lodge shall contain not less than two signatures, including the signatures of two of the following: Spencer Wilkinson, Jr., Patrick Packineau, Felicia Jarski or Madeline Cerese Baker.

**CERTIFICATION**


