

## OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled "Limited Waiver of Sovereign Immunity For the Benefit of the United States for USDA Loan and Grant."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Three Affiliated Tribes Constitution and Bylaws authorizes and empowers the Mandan, Hidatsa and Arikara Tribal Business Council to engage in activity on behalf of and in the best interest and welfare of the Tribes and the enrolled members thereof; and

WHEREAS, The Three Affiliated Tribes has applied for a USDA loan in the amount of \$2,509,000 and a grant in the amount of \$1,000,000 to help finance the Rural Water Development Supply System Project; and

WHEREAS, By letter dated June 12, 2003, the USDA issued a Letter of Conditions to the Tribe with respect to the award of said loan and grant; and

WHEREAS, One of the conditions with respect to the award of said loan and grant is that the Tribe waive its immunity from suit with respect to the enforcement of rights in the event of default by the Tribe with respect to said loan and grant; and

WHEREAS, The Tribe is willing to waive its immunity from suit for said limited purposes.

**NOW, THEREFORE, BE IT RESOLVED,** that the Three Affiliated Tribes hereby agrees to waive its immunity from suite for the limited purpose of allowing the United States of America to enforce any rights it may possess under the terms of the \$2,509,000 loan and \$1,000,000 grant to the Tribe as follows:

The Three Affiliated Tribes hereby expressly waives its immunity from suit **for** any action taken to protect and enforce rights following an Event of Default by the Tribe **of** any obligations assumed by the Tribe in connection with the Water Loan of \$2,509,000 and grant for \$1,000,000 to be issued by the Rural Utilities Service to the Tribe provided, however, that Three Affiliated Tribes' waiver of its sovereign immunity is expressly limited to actions brought to enforce the debts and obligations of the Tribe pursuant to the Loan Resolution, Security Agreement, Financing Statement, and the Promissory Note. This waiver is specifically limited to the amount of money loaned or granted to the Tribe by USDA under the aforementioned loan and grant. This waiver of immunity from suit shall terminate upon payment in full of the Tribe's obligations under the Promissory Note. This express and unequivocal waiver shall be made a part of the loan documents or grant agreement executed by the Tribe and the USDA. Any dispute that arises under the aforementioned documents shall be brought in a court of competent jurisdiction.
