

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Tribal Housing Division, Applications Scored by Time and Qualifications."

- WHEREAS, this Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Three Affiliated Tribes' Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and
- WHEREAS, the Tribal Housing Division has been created by the Tribal Business Council for the purpose of constructing homes for the members of the Three Affiliated Tribes and developing financial resources for the occupant members of the homes for the lease or purchase of the homes, including but not limited to the Dreamcatcher program, the Elder Homes Program and the Home Buyer Assistance Program; and
- WHEREAS, the Tribal Housing Division has developed qualifying criteria by and through approved policies for the selection of individuals for the lease or purchase of homes acquired and constructed by the Tribal Housing Division; and
- WHEREAS, the homes acquired and constructed by the Tribal Housing Division are in great demand and a competitive market requires that the policies for the selection of individuals for the lease or purchase of the homes be administered timely and fairly in order to serve the housing needs of the entire membership of the Three Affiliated Tribes; and
- WHEREAS, it serves the best interest of the members of the Three Affiliated Tribes that decisions of selection of applicants for occupancy of the homes ready for lease or purchase as developed by the Tribal Housing Division be made fairly and timely, meaning that applications must be scored according to first date of completion of "qualified" applications for housing and that the applicant must qualify according to the policy approved and set forth by the Tribal Housing Division.
