

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of Certification of Loan Resolution Security Agreement Regarding the North Segment Community Center."

- WHEREAS, this Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Three Affiliated Tribes' Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, on September 25, 2001 the Tribal Business Council passed a Loan Resolution Security Agreement pertaining to a \$2,507,000.00 loan from the United States Department of Agriculture for the North Segment Community Center; and
- WHEREAS, the Tribal Business Council approved of the Loan Resolution Security Agreement by a vote of 6-0 and said Agreement was signed by the Tribal Chairman and Tribal Secretary but was never certified; and
- WHEREAS, the United States Department of Agriculture is requiring a "re-certification" of this Agreement; and
- WHEREAS, the Tribal Business Council desires to "re-certify" said Agreement and reaffirms its commitments under said Agreement.
- NOW THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby "re-certifies" the Loan Resolution Security Agreement passed by the Tribal Business Council on September 25, 2001 by a vote of 6-0 and further reaffirms its commitments under said Agreement. The Tribal Secretary shall sign said Agreement and attach this Resolution thereto for presentation to the United States Department of Agriculture.


