

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Arline Fox Muzzy aka Arla Jean Fox Muzzy Land Exchange w/the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Natural Resources Committee of the Tribal Business Council approved the exchange of property described below; and
- WHEREAS, It has been determined that it is in the best interest of the Tribe to exchange the land; and
- NOW, THEREFORE, BE IT RESOLVED, The Three Affiliated Tribes' Tribal Business Council approved the exchange of land, exclusive of minerals, with:

#### Arline Fox Muzzy aka Arla Jean Fox Muzzy, 301-U2429

and hereby authorizes the Chairman of the Tribal Business Council, It's Secretary, and the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the land to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation and to Arline Fox Muzzy aka Arla Jean Fox Muzzy under the terms and conditions as stated on the attachment; and

**FINALLY BE IT RESOLVED**, Resolution No. 92-056-JJR dated May 18, 1992 be rescinded in its entirety; said Resolution approved a land exchange between the Three Affiliated Tribes and Arline Fox Muzzy.
