A Resolution entitled, "Relinquishment of Maynard Good Bear, Jr."

- WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS,** The Constitution of the Three Affiliated Tribes generally Authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the enrolled members; and
- WHEREAS,** The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls and;
- WHEREAS,** Maynard K. Good Bear Jr. 301U-06487 requested relinquishment of his/her membership from the Three Affiliated Tribes, Membership has been requested and approved with the Leech Lake Band of Ojibwe, Cass Lake Minnesota, and
- WHEREAS,** A copy has been received of application confirmation from the Leech Lake Band of Ojibwe.

NOW THEREFORE BE IT RESOLVED, that Maynard K. Good Bear Jr. 301U-06487 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.

BE IT FURTHER RESOLVED, that the Leech Lake Band of Ojibwe, is advised with a copy of this resolution.



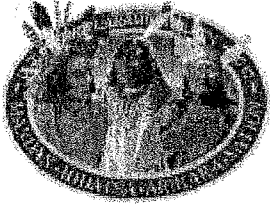
