



RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Karl Big Pond Land Sale to the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Natural Resources Committee of the Tribal Business Council approved the purchase of property described below; and

NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes' Tribal Business Council approved the purchase of land, exclusive of minerals, from:

Karl Big Pond, 30I-U4996

For a cash consideration of \$5,691.00, which is the actual value, utilizing funds from the Docket 350-G Land Purchase Account and hereby authorizes the Chairman of the Tribal Business Council, It's Secretary, and the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the land to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit:

Allot. No. 1705, an undivided 1/12 interest within the W1/2NW1/4 Section 11, T148N., R92W., Fifth Principal Meridian, North Dakota containing 80.00 acres, more or less, of which her interest is 6.67 acres, more or less valued at \$1,249.00.

Allot. No. 1018A, an undivided 1/12 interest within SE1/4 Section 10; NE1/4 Section 15, T148N., R92W., Fifth Principal Meridian, North Dakota containing 320.00 acres, more or less, of which her interest is 26.67 acres, more or less valued at \$4,442.00.
