**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

**WHEREAS,** The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** In accordance with Public Law 97-35, the Office of Community Services, U.S. Department of Health and Human Services, has invited the Three Affiliated Tribes to submit a FY-2005 Application for funding for outreach workers pursuant to Public Law 97-35; and

**WHEREAS,** Social Service's Material Resource Department has prepared an application for a FY-2005 Community Services Block Grant which, if awarded, will fund two community outreach workers for the Tribe; and

**WHEREAS,** The Tribal Business Council finds that the application is in the best interest of the Tribe and desires to approve the same.

**NOW THEREFORE BE IT RESOLVED,** That the Tribal Business Council of the Three Affiliated Tribes duly authorizes the execution and filing of the Community Services Block Grant FY-2005 Application including all understandings and assurances contained in the application, and hereby authorizes the Chairman of the Three Affiliated Tribes to serve as the official contact person for the Three Affiliated Tribes Community Services Block Grant Program and to execute all documents necessary to process the application.
