

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Authorization of FY 2005 Native American Library Services Grant Application by the Fort Berthold Community College"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- **WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, Article VI, Section 5 (c) authorizes the Tribal Business Council to administer any property or funds within the exclusive control of the Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and
- WHEREAS, the Tribal Business Council has previously authorized the Fort Berthold Community College to apply for the Native American Library Services Grant through the Institute of Museums and Library Services and to operate the Fort Berthold Library with said grant funds; and
- **WHEREAS**, the Fort Berthold Library provides circulation, reference and other general library services for the Fort Berthold Indian Reservation population; and,
- WHEREAS, The Three Affiliated Tribes intends to submit grant applications for the Native American Library Services grant under the Institute of Museums and Library Services for Fiscal Year 2005; and
- **WHEREAS**, The Three Affiliated Tribes, with the Fort Berthold Community College as contractor, intends to request funding to continue the provision of basic library services; to improve the level of professional proficiency; enhance library service delivery; and continue collection development and management of operation on the Fort Berthold Indian Reservation.



VOTE: 6 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried.

30. <u>**RETURN OF TAT EQUIPMENT, WASTE MANAGEMENT, ROADS, & FIGURE</u> FOUR:**</u>

Councilman Spotted Bear moved to have CEO contact the Figure Four Ranch and TEC Industries and locate equipment [Four Bears Waste Management Back Hoe from the Figure Four Ranch. Roads Department's Track Hoe/Back Hoe from TEC Industries that was left at Skunk Bay], and to collect any rental fees. Councilman Hale seconded the motion.

31. PARSHALL AFTER PROM REQUEST-COUNCILMAN PACKINEAU

Councilman Packineau moved for approval to grant \$300 for all high school on the Fort Berthold Indian Reservation to subsidize costs for their After Prom Dance. Councilman Hale seconded the motion.


