


## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval of the EPCM Agreement Between TRIAD and the Three Affiliated Tribes Subject to Certain Conditions."

- WHEREAS, This Nation having accepted the Indian Reorganization act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article IV Section 5(d) of the Tribes Constitution specifically authorizes the Tribal Business Council to negotiate with the Federal, State and local governments on behalf of the Tribes; and
- WHEREAS, The Tribal Business Council supports and has been working on the development of an oil refinery on the Fort Berthold Reservation which will be owned by the Three Affiliated Tribes; and
- WHEREAS, The Three Affiliated Tribes has substantially completed Phases I & II of the oil refinery project and it is now time to move forward with Phase III of the project; and
- WHEREAS, Phase III of the Project involves the development of the Engineering, Procurement, Construction Management of the oil refinery; and
- WHEREAS, Triad Project Corporation has been retained by the Tribes for the Project and has developed the Front End Engineering Design and substantially completed the Business Plan for the Project; and
- WHEREAS, Triad Project Corporation (Triad) has also proposed to do the Engineering, Procurement, Construction Management (Phase III) of the Project; and
- WHEREAS, Triad has indicated a desire to assist the Tribes in finding and obtaining the funding necessary to cover the costs associated with Phase III of the Project; and

- WHEREAS, Triad desires to enter into an agreement with the Tribes to provide EPCM services to design and build the Refinery in light of the Tribe's reliance on TRIAD in development of the Refinery to date; and
- WHEREAS, TRIAD desires to perform the Work all upon the terms and conditions and for the consideration set forth in the Agreement for the EPCM for the Project provided that the Tribes obtain the funding necessary for the agreement and provided further with the understanding that the Agreement is approved subject to legal review and approval.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council hereby approves of the EPCM Agreement between TRIAD and the Tribes provided that the Tribes first obtain the funding necessary to cover the costs associated with performance of the agreement and provided further with the understanding that the Agreement is approved subject to legal review and approval.

NOW, THEREFORE, BE IT FINALLY RESOLVED, that Tribal Chairman is authorized to execute said agreement subject to the conditions provided above.

## **CERTIFICATION**
