- A Resolution entitled, "Nelson Bird Bear Land Exchange with the Three Affiliated Tribes"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act, and
- WHEREAS. The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS. The Natural Resources Committee of the Tribal Business Council approved the exchange of land between the Three Affiliated Tribes and Nelson Bird Bear, under the terms and conditions stated below; and
- NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes' Tribal Business Council approves the exchange of lands described below, exclusive of minerals, held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust status by the United States of America for Nelson Bird Bear, 301-U1611, hereby authorizes the Chairman of the Tribal Business Council, its Secretary, and the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the Tribe and Nelson Bird Bear, under the terms and conditions as stated below:

### Nelson Bird Bear

Allot. No. 771A, an undivided ½ interest within N1/2 Sec. 36, T149N., R93W., Fifth Principal Meridian, containing 320.00 acres, which his interest is 160.00 acres, valued at \$34,249.00.

#### Tribal Land

Allot. No. T997A-A, N1/2SE1/4, S1/2NE1/4 Sec. 28, T150N., R94W., Fifth Principal Meridian, containing 160.00 acres valued at \$27,600.00. The Tribe will pay the difference of \$6,649.00, upon availability of funds.
