Councilman Whitecalfe moved for approval to direct the Natural Resources Department the authority to do a tribal declaration declaring a state of emergency of the Twin Buttes Intake. Councilman Hale seconded the motion.

DISCUSSION:

Once we get that draft up and signed by the Chairman, we're going to move it up in line to FEMA, then the Governors has to sign it is what they told us last night, Reason for that emergency is when we get to 1797 which they're saying is the water is going to get to by this fall and Twin Buttes is going to be high and dry. So we're trying to go after the Corps of Engineers to get this money thru this process. Well we could call a Special to get your reso and signature. If you guys would just do a motion now. Area a State of Emergency.

Mr. Steve Kelly said he would do the Resolution, and if I could explain exactly what act we're going under and everything,. There's an act we're going under and it's called the Stafford Act that provides for Federal Emergency FEMA In order to get these FEMA funds only the Governor of the State can declare a State of Emergency to get those funds and that's what triggers those funds. Because we talked to the Corp about getting some of those monies they said they couldn't unless we declared a State of Emergency by the local governing body to pass a resol declaring a state of emergency, then the Governor would sign certain primeters you got to meet to have a state of emergency. Dan Iseral latest report Bsrtlett & West to keep the corp from discharging the water.
