



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled "Authorization for Payment Of Dues To NCAI and Appointment of NCAI Delegates."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Three Affiliated Tribes Constitution and Bylaws authorizes and empowers the Mandan, Hidatsa and Arikara Tribal Business Council to engage in activity on behalf of and in the best interest and welfare of the Tribes and the enrolled members thereof; and

WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and

WHEREAS, The Three Affiliated Tribes has met all requirements for Tribal Membership to the National Congress of American Indians ("NCAI"), pursuant to Article II, Section II(a) of the Constitution of NCAI; and

WHEREAS, Three Affiliated Tribes Tribal Business Council desires that the Tribe remain a Member Government in Good Standing of NCAI; and

WHEREAS Three Affiliated Tribes Tribal Business Council desires to appoint Chairman Tex Hall as the Tribes' delegate to NCAI and Vice-Chairman Mervin Packineau as the alternate delegate.

NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby authorizes payment of NCAI dues in the amount of \$1,000.00 for continued membership for the year 2005-2006.

BE IT FURTHER RESOLVED, that, based on the tribal enrollment of 11,000 members, the Tribe shall have 180 votes in accordance with Article III, Section II(a) 4 of the NCAI Constitution and Bylaws; and

BE IT FINALLY RESOLVED that pursuant to Article III, Section II(A)2 and 3 of the NCAI Constitution, the Tribal Business Council designates Chairman Tex Hall as the Tribes' delegate to NCAI and Vice-Chairman Mervin Packineau of the alternate delegate.




CERTIFICATION


