



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Adoption of Fiscal Year 2006 General Fund Budget in the amount of \$26,392,736.50 "

- WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS,** Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS,** Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds or property within the exclusive control of Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and
- WHEREAS,** the Tribal Business Council has been operating under a General Fund Continuing Budget Resolution for FY 06 based on the FY 05 Budget pursuant to Resolution 05-157 NH; and
- WHEREAS,** The Tribal Treasurer has presented a proposed FY 2006 General Fund Budget in the amount of \$26,392,736.50 to the Tribal Business Council for approval; and
- WHEREAS,** said proposed FY 06 General Fund Budget includes a \$7,159,621.85 deficit and the Treasurer is recommending approval of said Budget and deficit under the condition that the deficit be funded through a line of credit or loan; and
- WHEREAS,** the Tribal Business Council has reviewed the Tribal Treasurer's proposed FY 06 General Fund Budget and has determined that it should be adopted; and
- WHEREAS,** Federal fund revenue shortfalls and expired Federal Grants have caused the TAT Business Council to fund these activities and has resulted in these over expenditures; and



WHEREAS, the Tribal Business Council will review current revenue items specifically Indirect Cost, Third Party Billing and current litigation to increase these line items.

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby adopts and approves the attached FY 06 General Fund Budget with a \$7,159,621.85 deficit under the condition that a loan or line of credit be secured to cover the deficit.
