- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 3 of the Constitution of the Three Affiliated Tribes grants the Tribal Business Council all necessary sovereign authority including judicial authority which the Tribal Business Council is further authorized to delegate to the Tribal Court in order to exercise the jurisdiction granted in Article I of the Constitution; and
- WHEREAS, Title I, Chapter 1, Section 4.2 of the Fort Berthold Tribal Code specifically authorizes and directs the Tribal Business Council to appoint licensed attorneys to each serve in the capacity of Associate Judge on a calendar year basis; and
- WHEREAS, It is the considered judgment of the Tribal Business Council that the Judiciary of the Three Affiliated Tribes must maintain exceptionally qualified judicial officers to uphold the laws and customs of the Tribes; and
- WHEREAS, On the recommendation of the Tribal Court, the Tribal Business Council has selected Peter Furuseth, B.J. Jones, and Terry Pechota to serve as the rotating Associate Judges in the Fort Berthold District Court during calendar year 2006; and
- WHEREAS, The above-named individuals are licensed attorneys and have significant experience in the area of federal Indian law and with tribal judicial forums.

NOW, THEREFORE, BE IT RESOLVED, the Tribal Business Council of the Three Affiliated Tribes hereby formally appoints Peter Furuseth, B.J. Jones, and Terry Pechota to serve as Associate Judges in the Fort Berthold District Court during calendar year 2006.

BE IT FURTHER RESOLVED, the Tribal Business Council hereby directs the Fort Berthold District Court to prepare the appropriate consultant agreements which shall be subject to review by the Tribe's Legal Department for the respective appointees identified hereinabove, and to specify that the rate of compensation shall be Five Hundred Dollars (\$500.00) per day while presiding over the court in addition to reimbursement of documented travel expenses.
