

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Tribal Business Council Appointment to the Board of United Tribes Technical College".

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The United Tribes of North Dakota ("United Tribes") is an association of the five federally recognized Tribes located in North Dakota, each of which has a government-to-government relationship with the United States established by Treaty, including the Three Affiliated Tribes, the Sisseton Wahpeton Oyaté, the Standing Rock Sioux Tribe, the Spirit Lake Tribe and the Turtle Mountain Band of Chippewa, with a Board of Directors composed of the Chairman and one council member from each member Tribe; and
- WHEREAS, United Tribes exists to assist in furthering the common goals of the North Dakota Indian Tribes and Nations; and
- WHEREAS, The UTTC Board is ten members comprised of the Tribal Chairman or President of North Dakota's Five Tribes and one appointed member from each Tribe; and
- WHEREAS, Former Chairman Tex G. Hall served as the Three Affiliated Tribes' appointed member of the UTTC Board; and
- WHEREAS, The Tribal Business Council desires to appoint Chairman Marcus Wells, Jr. to replace Tex G. Hall to the Board of UTTC and Vice-Chairman Nathan Hale as the alternate.

NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby appoints Chairman Marcus Wells, Jr. to replace Tex G. Hall as the Three Affiliated Tribes' representative on the UTTC Board and Vice-Chairman Nathan Hale as the alternate Board member.
