

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution Entitled: "Marcus Wells, Jr., Resumption of Duties as Vice Chairman of the Tribal Business Council."
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article III, Section 5 of the Tribal Constitution and Bylaws, the Tribal Business Council elected a Vice-Chairman, a Secretary, and a Treasurer from among its members under Resolution No. 04-01-NH on the fifth day of November 2004; and
- WHEREAS, Marcus Wells, Jr. was appointed as the Vice Chairman; and
- WHEREAS, Councilman Wells was authorized to take administrative leave during the months of September 2005 through January 2006 pursuant to Resolution 05-131-NH on September 12, 2005; and subsequently through January 2006 by Resolution 06-02-NH for the purpose of attending basic training and Advanced Individual Training in the United States Army Reserve; and
- WHEREAS, Councilman Marcus Wells, Jr., for the sake of the every day operations of the Mandan, Hidatsa and Arikara Nation, relinquished the position of Vice Chairman to Councilman Mervin Packineau until his full-time return; and
- WHEREAS, Councilman Marcus Wells, Jr. has, as of this date, returned full-time; and so

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby acknowledges Councilman Wells' resumption of the duties of the position of Vice Chairman.
