## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled: "Authorization for the Mandan, Hidatsa & Arikara Nations Tribal Tourism Department to Administer the Tribe's 2006 National Park Service Challenge Cost Share Grant-Project #FY06-99"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business

  Council has the power to adopt resolutions regulating the procedures of the Tribal

  Business Council and other Tribal agencies and Tribal officials on the

  Reservation; and
- WHEREAS, the Tribal Business Council has authority according to the terms of said

  Constitution to assign duties to its Programs and Departments and pursuant to said
  powers the Tribal Business Council has established the MHA Nation Tourism
  Department for the purpose of promoting tourism and tribal culture on the Fort
  Berthold Reservation; and
- WHEREAS, The MHA Tribal Tourism Department was instrumental in the planning and preparation of the National Lewis and Clark Bicentennial Signature Event which was held in Four Bears in August 2006, and
- WHEREAS, The Tribal Business Council has been advised that there are federal grant funds remaining, specifically the CSC Grant, awarded by the National Park Service-Project # FY06-99 for the Signature Event, which need to be closed out and in addition there are outstanding accounts payable for the Signature Event that need to be processed.



NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby assigns the MHA Tourism Department the authority and responsibility to administer the Tribe's 2006 CSC National Park Service Grant-Project 06-99 which was awarded to the Tribes for the Lewis and Clark National Signature Event and to close said Grant out in accordance with the terms of the Grant.
